

### Terms and Conditions of "HOME OPEN AGREEMENT" Promotion

1. These Rules and Regulations (hereinafter referred to as: "Rules and Regulations") specify terms and conditions of promotional Membership HOME OPEN AGREEMENT (hereinafter referred to as: "HOME OPEN AGREEMENT") offered by Zdrofit spółka z ograniczoną odpowiedzialnością, ul. Mangalia 4, 02-758 Warszawa, KRS number: 0000643347, NIP [Tax Identification Number]: 113 253 95 87, share capital of PLN 502,050.00 (hereinafter referred to as: "Zdrofit").
2. HOME OPEN AGREEMENT is a membership available in promotion in selected Zdrofit Clubs. Information about whether HOME OPEN AGREEMENT is available in a certain Club can be received directly in this Club or on Zdrofit website at [www.zdrofit.pl](http://www.zdrofit.pl).
3. HOME OPEN AGREEMENT entitles to unlimited use of gym and fitness classes only in one Zdrofit Club, in which it was purchased, without limitation within opening hours of the Club.
4. HOME OPEN AGREEMENT is concluded for an indefinite period. Each Party has a right to terminate it by giving one month's period of notice. The period of notice is counted from the first day of accounting period following the accounting period during which the notice was given.
5. Payment for HOME OPEN AGREEMENT is made in monthly settlement cycles, in advance for a specific month and is settled:
  - a) with the use of "Espago" cyclical payment system;
  - b) at the reception desk of the Club, in cash or by card (in such a case, the price of the Membership is increased by PLN 20.00 per month).
6. If HOME OPEN AGREEMENT is the first Membership purchased in Zdrofit, the Club Member receives a starter Voucher covering consultations with a coach and a body composition check. In order to use the starter voucher, the Club Member is obliged to choose the time when the voucher will be used with employees of the Club.
7. The fee amounts to PLN 99.00 (say: ninety-nine zloty) per month, save for item 9.
8. According to the information available in the Club and on the website [www.zdrofit.pl](http://www.zdrofit.pl), in selected Clubs an additional fee for the first month of HOME OPEN AGREEMENT is charged – in such case, the fee for the first month amounts to PLN 19.00 (nineteen zloty).
9. One can benefit from the promotion on the terms set forth herein once in 12 months, if it is applicable.
10. While purchasing HOME AGREEMENTS OPEN, the Membership Fee is not charged.
11. To all matters not settled herein, provisions of General Terms and Conditions of the Agreement and Rules and Regulations of Zdrofit Fitness Clubs available at the reception desk of Zdrofit Clubs, as well as on the website [www.zdrofit.pl](http://www.zdrofit.pl) apply.
